

## **IYOVIA Event Attendance Terms and Conditions**

These Event Attendance Terms and Conditions (“Terms and Conditions”) set forth the agreement between International Markets Live Inc dba IYOVIA and/or its affiliates (collectively “IYOVIA”) and you when you register or purchase a ticket for any event or convention organized by us or by an event organizer on our behalf (“Event”). By registering for an Event or purchasing an Event ticket organized by us you are agreeing to comply with these Terms and Conditions. Please read and download or print a copy of these Terms and Conditions before registering for or purchasing a ticket to attend an IYOVIA Event.

### **Acceptance of policies and registration conditions**

The following IYOVIA Registration Terms and Conditions (the “Terms and Conditions”) apply to all IYOVIA Events. Prior to your registration, you must acknowledge and accept the Terms and Conditions contained herein. If you do not wish to accept the Terms and Conditions you should not register. By submitting a registration for, or purchasing a ticket to attend an IYOVIA Event you accept these Terms and Conditions.

### **Registration and participation at the Event**

1.1. Your registration or ticket purchase entitles you to admittance to the Event for which you have registered or purchased a ticket subject to these Terms and Conditions. Any and all other costs associated with your attendance (including without limitation any travel and/or accommodation expenses) shall be borne solely by you, without limitation, any travel and/or accommodation expenses) shall be borne solely by you, and IYOVIA shall have no liability for such costs.

1.2. Registration for participation in the Event is made via the data form on the Event website. Please read and download or print a copy of these Terms and Conditions before you register or purchase a ticket to attend an IYOVIA Event.

1.3. Your registration will be confirmed by email. Upon receipt of your ticket, the contract for participation in the Event is concluded.

1.4. You acknowledge that IYOVIA reserves the right to request your removal from the Event if IYOVIA, in its sole discretion, considers your presence and/or behavior to create a disruption or to hinder the Event and/or the enjoyment of the Event by other attendees or speakers.

1.5. You acknowledge and agree that IYOVIA, in its sole discretion, reserves the right to change any and all aspects of the Event, including but not limited to, the Event name, themes, content, program, speakers, performers, hosts, moderators, venue and time. We are entitled to cancel the Event at any time for good cause (e.g. in cases of force majeure, too few participants, etc.) or where holding the Event becomes commercially impracticable. In such a case, you will be informed immediately of the cancellation.

1.6 To the extent permitted by law all Event ticket purchases are final and non-refundable.

### **How we will use your information**

2.1. IYOVIA is committed to data privacy and protecting your personal information. Information on how IYOVIA collects, processes, and uses your data is included in the IYOVIA Privacy Policy published at [www.iyovia.com](http://www.iyovia.com) which is hereby incorporated into these Terms and Conditions. Additionally, by submitting your email address during the Event registration process, you agree that IYOVIA and its event partners may send you Event-related information. A valid email address is required for all registrations.

2.2. IYOVIA uses the personal data you provide in this registration for administering your participation in the Event. Your data is also processed in our mobile application if you use it. This may include information about the Event’s

content, Event logistics, payment, updates, and additional information related to the Event.

2.3. IYOVIA may disclose your personal data to third party service providers engaged by IYOVIA to assist in the conduct of the Event. If these collaborative entities are located outside the European Union, an international transfer of data will take place. Information you provide when registering for or participating in an Event managed by parties other than or in addition to IYOVIA may be shared with those parties, and the treatment of such information is further subject to the privacy policies of those parties. Except as described herein, IYOVIA will not disclose your personal data to any other third party without your consent except where required to do so by law.

### **Conduct and Safety**

3.1. IYOVIA is committed to providing a safe, productive, and welcoming environment to all participants at IYOVIA-related Events. IYOVIA has zero tolerance for discrimination, harassment, or bullying in any form at IYOVIA-related Events. Participants are expected to adhere to these principles and respect the rights of others.

3.2. If you witness or are subjected to unacceptable behavior, you should report it to onsite Event staff. Event staff will assist participants in contacting venue security or local law enforcement, providing escorts, or ensuring safety. We value your attendance.

### **Liability waiver and release**

4.1. In consideration of being allowed to register for, and participate in the Event, I hereby warrant and represent that I am age 18 or above and to the extent permitted by applicable law, freely waive, release from liability, assume all risks, and covenant not to sue IYOVIA or its members, employees, officers, contractors, agents, or volunteers for any expense, loss, damage, personal injury, including loss of life, disability, property damage, or property theft or actions of any kind that I may hereafter suffer or sustain before, during, or after the Event, unless said expense, loss, damage, personal injury, including loss of life, disability, property damage or property theft or actions of any kind is caused by the sole, gross negligence of IYOVIA. This Liability Waiver and Release is specifically binding upon my heirs and assigns and is knowingly given.

4.2. You understand that any personal property you bring to the Event is there at your own expense and risk. IYOVIA does not concern itself with the security or insurance of your property. To the extent permitted by applicable law, you are liable for and must insure against any and all loss or damage of any nature, caused by your actions or omissions. You indemnify IYOVIA against any and all claims that third parties may bring against IYOVIA in connection with your actions or omissions.

### **Service as an invited speaker**

5. If you agree to speak at an IYOVIA-sponsored Event, we may share your contact and biographical information with Event attendees. Sometimes we may also request a photograph. We may also share with attendees and on the respective Event website information such as your name, geographical location, IYOVIA rank and a link to your company website and/or professional LinkedIn page or other social media pages available to the public. This is so that visitors to the Event website, including event attendees and speakers, can contact you with questions and requests for more information, and to provide feedback if needed. Additionally, speakers may be asked to complete a release agreement or copyright form prior to their presentation.

### **Usage of photographic and video material taken at IYOVIA events**

6.1. In general audio, image, and video recording is permitted at the Event. To comply with global data privacy laws, IYOVIA may impose certain restrictions on the use of multimedia at its events (e.g. photography, video, audio, online streaming, and all future mediums). An attendee is permitted to use hand-held cameras and/or smart phones

to take photographs and capture digital images for personal, non-commercial use, provided the photography is not disruptive. Photographs or video taken at IYOVIA Events may not be published, sold, reproduced, transmitted, distributed or otherwise commercially exploited in any manner whatsoever. IYOVIA reserves the right to restrict audio, image and or video recording of all or part of any IYOVIA Event at any time in its sole discretion.

6.2. During the Event, IYOVIA and its contractors will make photo and video recordings. By entering the Event venue, participants give their irrevocable consent to these recordings being made and the free use of their pictures/video shots and voice recordings for photography and video and/or audio recordings made by IYOVIA or their contractors in the context of the Event; as well as to the subsequent Internet exploitation on the websites of IYOVIA and their contractors; in the program of current or follow-up Events; and in promotional press reports on the part of IYOVIA.

6.3. IYOVIA may hire professional service providers (photo/video/streaming/audio) to document and display the Event experience. IYOVIA may also use social media (e.g. Instagram, Twitter) to: (i) post real-time photos and videos to its social media feeds; and (ii) display select submissions from those feeds on monitors throughout the Event venue. Attendees are encouraged to capture their Event experiences and post their own social content from the event (text, photos, audio, video, streaming), provided it does not infringe upon the rights of any attendee, sponsor, third party, or IYOVIA. Such infringement would include, but is not limited to, defamation or infringement of intellectual property rights. If an attendee requires a release or permission to protect the rights of a third party, obtaining such a release or permission shall be the sole responsibility of the attendee.

6.4. By attending the Event, you acknowledge and agree as follows: (a) IYOVIA may edit and use footage it captures at the event for marketing and promotional activities and for any other lawful purpose in the ordinary course of its business; and (b) due to the prevalence of mobile recording devices in today's world, IYOVIA disclaims all liability for the capture of your image in any multimedia format by other attendees at the Event.

### **Intellectual property**

7.1. All intellectual property rights in and to the Event, its content, and all distributed materials distributed at or in connection with the Event are owned by IYOVIA or its affiliates. You may not use or reproduce or allow anyone to use or reproduce any trademarks or other trade names appearing at the Event, in any Event content and/or in any materials distributed at or in connection with the Event for any reason without the prior written permission of IYOVIA.

7.2. For the avoidance of doubt, nothing in this Agreement shall be deemed to vest in you any legal or beneficial right in or to any trademarks or other intellectual property rights owned or used under license by IYOVIA or any of its affiliates or grant to you any right or license to any other intellectual property rights of IYOVIA or its affiliates, all of which shall at all times remain the exclusive property of IYOVIA and its affiliates.

### **Miscellaneous**

8.1. IYOVIA reserves the right to change, amend, add or remove any of the above Terms and Conditions in its sole discretion and without prior notice. If one or more of the conditions outlined in these Terms and Conditions should become invalid or unenforceable, the remaining conditions will continue to be valid and apply. These Terms and Conditions apply to all Event participants. We may from time to time and in our discretion notify you of additional terms that may be incorporated into these Terms and Conditions that govern a specific Event.

8.2. The views expressed by any Event attendee or speaker are not necessarily those of IYOVIA. All attendees and speakers are solely responsible for the content of all presentations.

8.3. These Terms and Conditions represent the complete agreement and understanding between you and IYOVIA and supersede all prior agreements and representations, commitments, or understandings, whether oral or written, made by or between you and IYOVIA with respect to the subject matter of these Terms and Conditions.

8.4. If any provision of these Terms and Conditions is determined by an authority of competent jurisdiction to be invalid or unenforceable in part or in whole for any reason whatsoever, the validity of the remaining provisions or portions thereof shall not be affected thereby, and such authority should reform these Terms and Conditions to the extent necessary in a manner that comes closest to expressing the intention of the invalid and unenforceable provision while rendering the otherwise unenforceable provision or portion thereof valid and enforceable.

8.5. The failure by IYOVIA to act with respect to a breach of these terms and conditions by you or others does not constitute a waiver and will not limit IYOVIA's rights with respect to such breach or any subsequent breaches.

8.6. You may not assign, transfer, or sublicense any or all of your rights or obligations under these Terms and Conditions without IYOVIA's express prior written consent. IYOVIA may assign, transfer, or sublicense any or all of its rights or obligations under these Terms and Conditions at any time and without your consent, and upon such assignment, IYOVIA shall be relieved of any and all duties, obligations, and/or liabilities arising from these Terms and Conditions. These Terms and Conditions shall be binding upon and inure to the benefit of the heirs, successors, and permitted assigns of the parties hereto.

8.7. Any use of the term "including" or variations thereof in these terms and conditions shall be construed as if followed by the phrase "without limitation."

8.8. Notices to you (including notices of changes to these terms and conditions) may be made via posting to the Event site or by e-mail. Without limitation, a printed version of these Terms and Conditions and of any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to these Terms and Conditions to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form.

8.9. These Terms and Conditions will be governed by and construed in accordance with the law of the State of Nevada, without regard to principles of conflicts of laws. The parties consent to jurisdiction and venue before any federal or state court in Clark County, Nevada.
